LOCAL RULES OF PRACTICE

The rules contained herein are adopted as the local rules of practice for the Bankruptcy Court for the District of Idaho effective October 1, 1979.

These rules supplement the Rules of Bankruptcy Procedure now in effect for the Bankruptcy Statute of 1898 now supplanted by Title 11, U.S. Code, effective October 1, 1979.

RULE I

INTERIM RULES

The following rules and forms promulgated by the Advisory Committee on Bankruptcy Rules of the Judicial Conference of the United States dated August 1, 1979 are adopted as interim rules for the District of Idaho, pending adoption of Revised Rules of Bankruptcy Procedure by the Judicial Conference of the United States, the U.S. Supreme Court and the Congress of the United States.

Rules 1001, 1002, 1003, 1004, 1005, 1006, 1007, 1008, 1009, 2001, 2002, 2003, 2004, 2005, 2006, 3001, 3002, 3003, 3004, 3005, 3006, 3007, 3008, 3009, 3010, 4001, 4002, 4003, 4004, 5001, 6001, 7001, 7002, 7003, 7004, 8001, 8002, 8003, 8004, 8005, 8006, 8007, 9001, and 13001. Forms No. 1 through 25.

RULE II

MASTER ADDRESS LIST

At the time of filing a petition initiating a proceeding under the Bankruptcy Code a master address list shall accompany the petition which shall be adequate to

produce address labels on standard office copying machines, and shall include the name, address, and zip code of every scheduled creditor, attorney of record, debtors and other parties in interest. Said names and addresses shall be spaced and located on the page containing the list as follows:

> From the top of a letter size sheet, the first address in the first column will begin 2 spaces down and indented 3 spaces. Second column starts 29 spaces from the left hand edge and the third column starts 58 spaces from the left hand edge. Each label is 1 inch wide. The bankrupt and/or debtor's name is first typed in CAPS, then attorney's name and then the creditors from Schedules A-1, A-2, and A-3, working from left to right. List each name and address ONCE.

RULE III

JURY TRIAL

All issues requiring trial by jury before the Bankruptcy Court shall be tried by a six-person jury drawn and impaneled pursuant to the rules and practice of the U.S. District Court for the District of Idaho.
