The following form of standard order shall be used for the deposit of registry funds into interest bearing accounts or the investment of such funds in an interest bearing instrument:


IT IS ORDERED that the clerk invest the amount of \$ \_\_\_\_\_ in an automatically renewable [type of account or instrument such as time certificate, treasury bill, passbook] in the name of the Clerk, U.S. District at [name of bank, savings and loan, brokerage house] said funds to remain invested pending further order of the court.

Pursuant to action taken by the Judicial Conference of the United States, IT IS FURTHER ORDERED that the clerk shall be authorized to deduct a fee from the income earned on the investment equal to 10 percent of the income earned while the funds are held in the court's registry fund, regardless of the nature of the case underlying the investment and without further order of the court. The interest payable to the U.S. Courts shall be paid prior to any other distribution of the account. Investments having a maturity date will be assessed the fee at the time the investment instrument matures.

IT IS FURTHER ORDERED that counsel presenting this order personally serve a copy thereof on the clerk or his chief deputy. Absent the aforesaid service, the clerk is hereby relieved of any personal liability relative to compliance with this order


This General Order supersedes General Order 57 entered by this court on September 15, 1989.


